## Fund activity during the month

- The Fund does not purchase any new Loan Investments during the month.
- The Fund's Loan Investments currently comprise 93.01% of the Fund's assets, with 6.51% of the Fund's assets currently being held in bank cash deposits.
- The current Loan Investment Loss Rate (**LILR**)<sup>8</sup> is 3.50% , which was unchanged from the previous Fund Report.
- The Fund's return for the month was 0.59%.<sup>9</sup>
- The distribution to investors for the month was 0.5853 cents per unit.
- For Delinquent Loan Investment incurred by the Fund – full principal amount was recovered through provision of funds in the Loan Investment Reserve Account. The loss incurred relates to the interest component of the loan.
