## Fund activity during the month

- The Fund has not purchased any new Loan Investments during the month.
- The Fund's Loan Investments currently comprise 72.81% of the Fund's assets, with 27.19% of the Fund's assets currently being held in cash deposits and other receivables.
- The current Loan Investment Loss Rate (**LILR**)<sup>9</sup> is 3.00%, which was unchanged from the previous Fund Report.
- The Fund's return for the month was 0.55%.<sup>10</sup>
- The distribution to investors for the month was 0.5542 cents per unit.
- For Delinquent Loan Investment sold by the Fund – full principal amount was recovered through provision of funds in the Loan Investment Reserve Account. The loss incurred relates to the interest component of the loan.
